**Sub:- Temporary approval of affiliation of
Geeta Institute of Law, Panipat, Haryana**

Sir,

The Bar Council of India at its meeting held on 30th June and 1st July, 2007 considered the recommendations of the Legal Education Committee made at its meeting held on 29th and 30th June, 2007 in respect of Geeta Institute of Law, Panipat, Haryana and took the following decision:-

"Legal Education Committee considered the verification report submitted by S/Shri Jagdev and D.R. Sharma, Members in respect of Geeta Institute of Law, Panipat, Haryana After consideration Committee is of the view that approval of affiliation to Geeta Institute of Law, Panipat can be granted with intake of one section in five year LLB course and two sections in three year LLB course for a period of two academic sessions i.e. 2007-2008 and 2008-2009 in accordance with the recommendations made in the verification report and subject to the following conditions.

1. The Institution has to pay UGC / State Govt. scales of pay to the staff.
2. The salary should be paid to the staff through account payee cheque.
3. The Institution has to purchase books for the library as per norms of the Bar Council of India every year.

The management is directed not admit students for this academic year before getting the order of affiliation from the concerned


The college shall also comply with the following Rule 23 Section A Rule 16 in Section B in Part IV of the Bar Council of India Rules respectively:-

"Whenever approval of affiliation is granted to the law college it shall necessary for the college to deposit in cash Rs.1,00,000/- (one lakh) in the shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if the norms are not complied with and the same shall carry no interest."

The approval of affiliation now granted by the Bar Council of India is subject to the payment of guarantee amount as mentioned in the above rule.

You are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India.
