Subject: - Provisional No Objection Certificate (NOC) for starting of Geeta Institute of Law for three years and five years Degree Course, Village Karhans, G.T. Road, Panipat. (Self financed).

You are hereby permitted to start the above mentioned college from the academic session 2006-07 on the following conditions:-

No financial assistance/grant in any form at any stage will be given by the State Government. The institution will have to bear all the recurring and non-recurring expenditure for all time to come.

The State Govt. shall not give any grant for building etc. at any time. The building intended for educational occupancy will not be used for any hazardous occupancy.

The State Govt. shall not take over the college at the request of the Institution.

All the conditions of affiliation prescribed by the affiliating University/University Grants Commission/Bar Council of India will have to be met by the Institution.

The institution shall seek approval and affiliation from a University in the State of Haryana and Bar Council of India and send the copy of the approval/affiliation to this office.

The college authorities will recruit the staff as per Government/affiliating University guidelines and pay the salary to the staff in the pay scale prescribed by the Govt. from time to time.

Student fee and other charges will be as per the norms of the affiliating University/State Govt.

In the admission of the students there shall be reservation of seats for SC/BC/OBC/ Handicapped/ ex-servicemen/ Sports Persons/ Freedom-Fighters and any other reserved category as per the State Govt. Policy.

No discrimination on the basis of caste/creed/color/sex/religion shall be made while recruiting the faculty.

The institution will appoint qualified teachers in reduced number as per norms and submit report to this effect for admission. The institute shall also submit a copy of the existing and proposed teaching infrastructure to this office.

The Government can make any other stipulation at any time which shall be mentioned on the Certificate.

Provisional NOC for the first year is given because the basic minimum infrastructure are available to run the proposed course(s). However the NOC can be extended for another two years on year-to-year basis. But the institution has to develop the infrastructure as per terms and conditions.

The institute shall submit a Progress Report pertaining to the infrastructure/financial status/ performance of the institute to the HEC at the end of its first year for review and grant of continuation of the Provisional NOC by 30<sup>th</sup> April of the end of first year and another Progress Report by 31<sup>st</sup> March of the end of 2<sup>nd</sup> year for consideration for PERMANENT NOC failing which the provisional NOC shall be withdrawn.

14. Endowment Fund in the shape of FDR of Rs. 5.00 lacs pledged in the name of Higher Education Commissioner, Haryana is to be deposited in the account within 15 days of issuance of NOC. In case, the institute is not able to deposit itself the NOC shall be withdrawn and the Endowment Fund of the sum of FDR Rs.5.00 lacs submitted by the Applicant shall be forfeited to complete the studies of the enrolled students/for the payment of the salary of staff and for other costs of running the institute and just in case the funds available in the college are not sufficient, the balance amount shall be recovered from the applicant society/trust/company/individual(s) as per the Law of State.

15. NOC is granted for the both course i.e. three years and five years. Condition that admission will be done after the approval of Bar Council of India etc.

16. Any contravention of the above stated conditions shall result in withdrawal of "No Objection Certificate" and legal action against the defaulting society/institution.
